#### 5. **Proposed amendments to League Rules**

## (a) Committee Proposals and rule changes:

- Team responsibilities
  - o Add rule 6 Any team who does not return award trophies by February 1st in the current season, or if trophies are returned damaged or broken, will be fined £25. Unanimous

  - Correction to Rule 21 word 'cancellation' be replaced with 'rearrangement'. Unanimous

  - o Addition to Rule 27

Knock-Out Cup fixtures will be umpired by the qualification set for league matches as per rule [32]. Neutral umpires will be appointed from the quarter finals.

- (a) In the unlikely event of a cancellation, the defaulting team must notify the opposing team and both umpires.
- (b) Any defaulting teams from the quarter finals onwards, without 48 hours prior notice, will be fined £25

**Umpires and Scorers** 

Amendment to Rule 31a

- Division 1 home team must be umpired by B award or above.
- Away team may be umpired by a B award or above
- o or an umpire on the C Approved List [until the 2025-26 season]
- o or a C Award working towards their B award qualification and who has passed their AB written paper [provided they are still within their 2 years post-completion validity period].

**Unanimous Carried** 

Add Rule 31e – Any team umpired by an umpire of the wrong qualification will lose any points gained from that match and will incur a fine not exceeding £25. The nonoffending team will be awarded the points plus 20 goals and the offending team will be deducted 10 goals. In the event that both teams are umpired by an umpire of the wrong qualification then no points or goals will be awarded or deducted.

Division 1 games in order to gain match practice in advance of their B award test.

Amendment to Rule 51 – Subject to assessments, team withdrawal and the Committee's discretion at the end of the season, at least the top two teams in each division will be promoted to the next higher division and the bottom two teams may be relegated to the next lower division. Should two teams draw for promotion or relegation the better team shall be judged on goal difference throughout the season. If this is still equal, then the Committee shall arrange a play-off and neutral umpires will be appointed. In the event of a play-off being a draw then Rule will apply.

Blackwater Pearls

Amendment proposed to rule 46 of the Handbook - proposal to remove the rule: Rule 46 currently reads "Pregnancy: No player is allowed to play after 12 weeks and umpire after 20 weeks."

England Netball and World Netball guidance on this has changed. England Netball follow World Netball's pregnancy guidance, which says – in short – that the decision to play netball during pregnancy is ultimately the participant's choice and emphasises the importance of seeking medical advice due to the inherent risks.

Rule to stay as in current handbook and teams advised to refer to the England Netball website as to their guidance for playing whilst pregnant and England Netball insurance cover stance.
